#### **Application Instructions**

- Return completed applications and processing fee to: 800 All America City Blvd. Roseville, CA 95678
- 2. A \$10.00 non-refundable processing fee (payable to @the Grounds) is required with each application. We accept cash, check, or credit card with an additional \$1 fee for credit card transactions. No space fee is due at this time if a contract is issued you will be billed and a deposit to reserve your space required.
- 3. The last date to submit an application is April 1, 2019.
- 4. We will notify you no later than April 15, 2019 about your selection into the 2019 Placer County Fair.
- 5. This application is neither an offer nor guarantee of space.
- 6. Make sure all information on this application is correct. This will be the only information the selection committee will base its decision on. If you provide inaccurate information on your size and electricity needs, accommodations may not be provided for.
- 7. The list of food items you are requesting to sell must be specific. If a contract is issued, it will be assigned off of this list only.
- 8. A photo of your food stand in operation is required with each application.
- 9. You must attach a copy of your CA Seller's Permit to this application to be considered for selection.
- 10. The cost for a concession stand at this year's Placer County Fair is \$350 with 25% of gross sales due plus additional fees as necessary.
- 11. If a contract is issued, the location of your stand will be determined by management. You will be notified of your location prior to arrival. Every attempt will be made to place vendors in a location most favorable for their products.

Additional instructions and requirements will be sent to you if a contract is issued.
